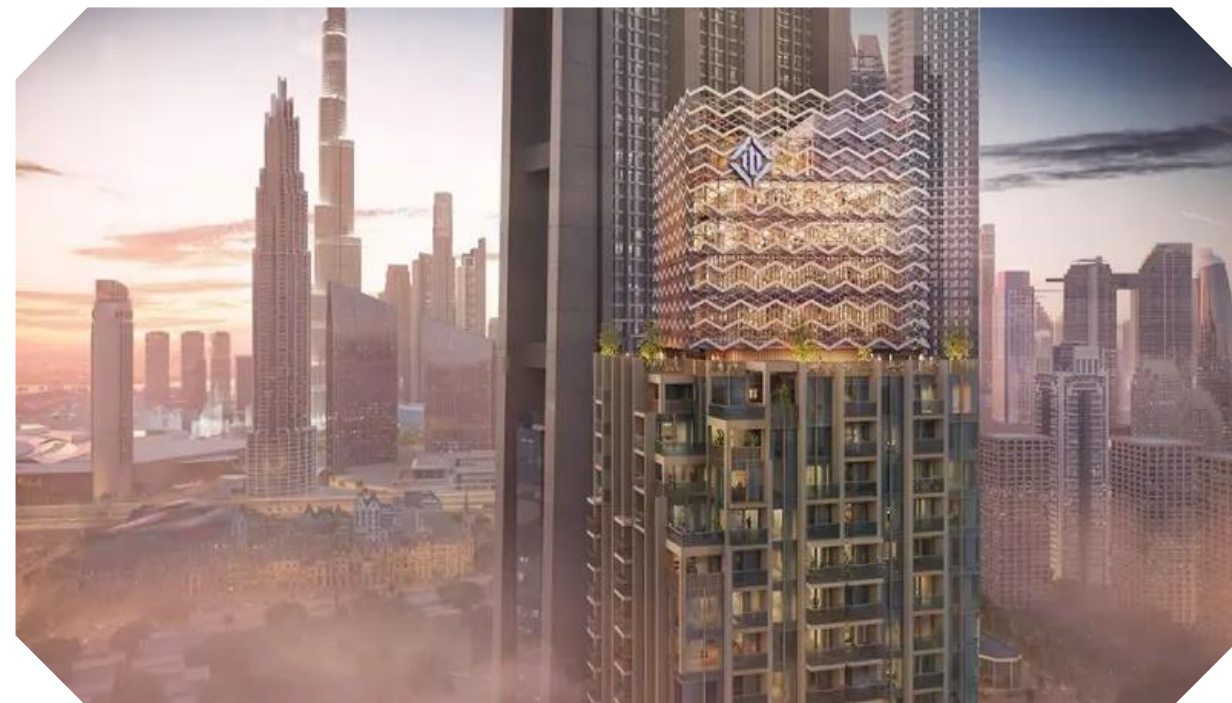
The **Dubai AI Campus** is the DIFC Innovation Hub's latest new venture to be headquartered at DIFC's new "Innovation One" premises.

Dubai AI License

DIFC launched the **Dubai AI License** to provide AI developers and entrepreneurs with enhanced flexibility, cost benefits, and opportunities for growth from the largest AI campus.

The **Dubai AI License** is a **90%** subsidized commercial license for AI firms who are looking to set up in the MENA region.

1. Subsidized Commercial Licensing at **USD 1,500** (annual fee) + **USD 100** one-time registration fee
2. Access to **co-working space** - flexible desk at **USD 6,000(+VAT)** per year
3. Up to **4 visas** on the first desk; **40% discounted** visa costs

The confirmation statement will include a confirmation that all information (& any changes to such information) required to be notified to the DIFC ROC has been so notified.

Dubai AI License Process

The full incorporation takes 3-4 weeks.

Stage 1: Submit for In-Principal Approval

Step 1

Fill out and **submit** your online [Initial Approval application](#)

- **Please ensure to select option “Yes” for the Digital Passport Verification to speed up process.**

Step 2

Your application is **under review** for Initial Approval

Step 3

In-Principal Approval obtained

Stage 2: Register the legal entity

Step 1

Submit the relevant documents and make your **payments** (credit/debit card, bank transfer, cash)*

Step 2

Incorporation Complete. Receive all **corporate documents** automatically via email.

Step 3

Renew your license annually & lease (depending on your payment method)

Visa (Costs + Application)

For individuals not applying for DIFC Visa

Access Card – Non-Sponsored

Applicable to Equity Holders (shareholders, members/partners) or **long-tern Visa holders that have an existing visa and do not want to transfer their visas to DIFC for fee.** The card is valid for 1 year or 2 years, can be renewed upon expiry.

What should you submit?*

New Establishment card

- Valid DIFC commercial license

New Employment Visa

- Clear colored passport photocopy, including the personal details page
- Applicant's photograph
- Copy of employment contract signed by both parties highlighting the job title of the applicant
- Copy of the highest educational certificate attested by UAE embassy in the country of certificate origin

Application is done directly on [DIFC Portal](#)

- Obtain your commercial license
- Apply on the DIFC Portal for an Establishment card & New Employment Visa
- Pay related fees online

Establishment Card & PSA

What is an Establishment Card?

It is a card issued by the General Directorate of Residency and Foreigners Affairs in Dubai to allow an entity to submit employment visa applications. **It is for the entity who requires visas under DIFC and will not be required for those who are not in need of any visa. You can apply for visas under DIFC ONCE THE ENTITY IS INCORPORATED.**

What is a Personal Sponsorship Deposit (PSA)?

PSA is an agreement that must be signed with DIFC Authority if the entity wishes to sponsor employees.

*Kindly note that the above listed requirements are the standard requirements for the visa application and Federal Authority for Identity and Citizenship reserves the right to ask for other supporting documents even after submission of the application.

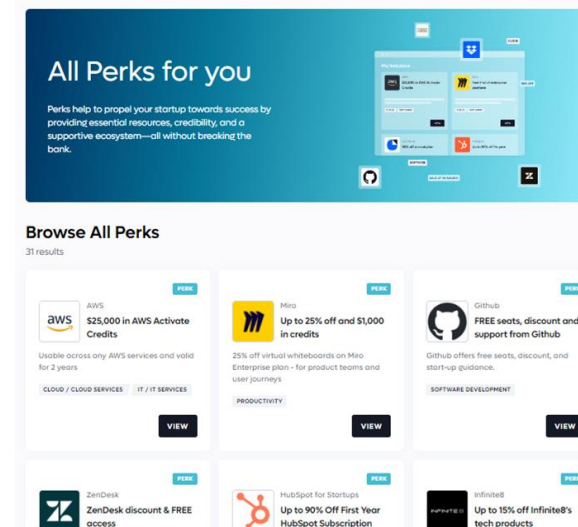
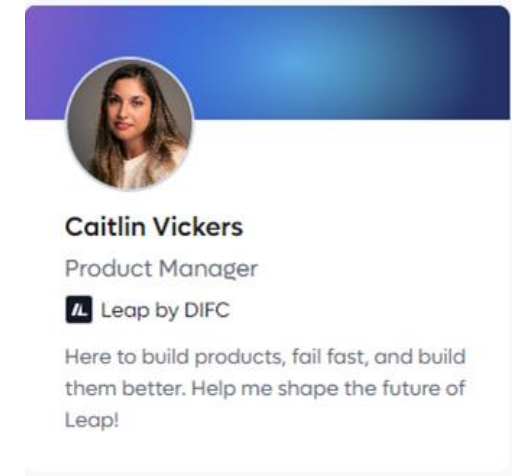
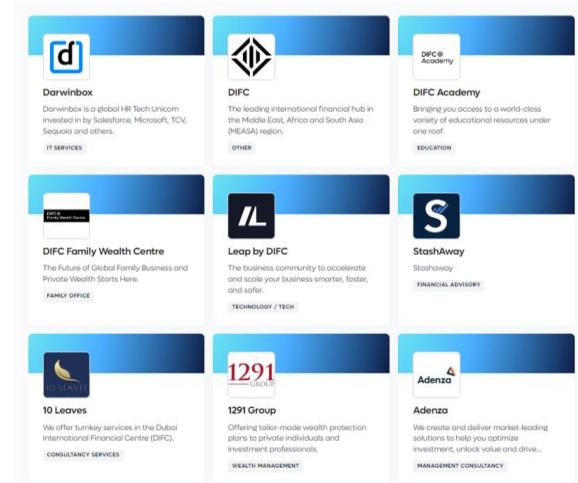
